The assignment will be in two parts, this (i) review of the existing designs, drawings and specifications for the Pipeline distribution within Akure City and its environs within 6 months under a lump sum contract; and (ii) supervision of the works contract for a contract duration of 18 months or the time estimated for the construction works under a time-based contract.
