### **1. PREAMBLE**

### **2. PROJECT SCOPE**

High tension and town distribution network electrification project at Rangwam to be completed within twelve (12) weeks

### **3. ELIGIBILITY REQUIREMENTS**

To be considered for pre-qualification, interested, competent and reliable contractors are required to provide verifiable evidence including but not limited to the following documents.

a) Certificate of Incorporation with Corporate Affairs Commission.

- b) Certified true copy of Memorandum and Articles of Association
- c) Evidence of registration with Jigawa State Work's Registration Unit
- d) Tax clearance certificate for the last three (3) years
- e) Audited account for the last one (1) year
- f) VAT registration and evidence of past remittance
- g) Evidence of financial capability and banking support
- h) Company average annual turnover of not less than N50, 000,000.00 naira.

i) Evidence of similar project executed (letter of award and completion certificate) at least(2) in the last five (5) years

j) Verifiable evidence of company profile and technical qualification of key personnel registered with relevant professional bodies (COREN, CORBON, QSRBN, ARCON etc)

k) That the company have fulfilled all obligations to pay taxes, pensions and social security contributions

l) A sworn affidavit certifying as follows:

a. That the document submitted for the pre-qualification exercise are not genuine but correct

b. That none of the directors of the company has been convicted by any court of law

c. That the company is not bankrupt

d. That none of the officers of Jigawa State/Local Government is a present or former director of the company

m) Any other relevant information that will help in determining the company's suitability for the works

n) Any prospective bidder that does not possess any of the above documents need not apply

Interested bidders are to collect the tender documents from the office of the Director Planning, Research/Statistics, Birnin Kudu Local Government from the date of publication of this advert and between the hour of 9:00am to 5:00pm daily after payment of nonrefundable fee of N50, 000.00k

## **5. SUBMISSION OF THE TENDER DOCUMENTS**

Technical and financial bids will be submitted in two different sealed envelopes and labeled "Technical bid "financial bid" respectively with the company's name indicated on one side of envelope. Both envelopes should be sealed in to the one bigger envelope also sealed and marked with the project name at the top right hand corner and address to: third envelope addressed and delivered to the office of the Director Planning, Research and Statistics, Birnin Kudu Local Government Jigawa State not later than **Wednesday**, **1st November**, **2023 by 12:00 noon**.

All document for submission must be transmitted with a forwarding letter duly signed by company representative under the company's letter headed paper bearing the CAC registration Number (RC), Contact Address, Telephone Number (Preferably G.SM No) and email address.

The financials bid should contains a bid security of not less than 2% of quoted bid, by way of a Bank guarantee or an insurance bond issued by a reputable bank or insurance company acceptable to the procuring entity.

The bid validity period should be six weeks from the deadline of the bid submission date.
