Sultan Maimalari Road from Idrisa Khadi Junction to Sir Kashim Ibrahim Way through Budum Roundabout Via State Psychiatric Hospital of 1.526 km (addendum to earlier publication of 10th October, 2023).

Bidding will be conducted in accordance with the open domestic bidding method and is open to all bidders.

- Sworn affidavit from court of competent jurisdiction in Nigeria, disclosing as follows:
 - (i) That the company is not in receivership.
 - (ii) Compliance with Public Procurement Law, 2019.
 - (iii) That the Director(s) has/have never been convicted by any court of law
 - (iv) That the Company has not been debarred by any Government Agency or an International Organization.
