(1) INTRODUCTION:

Chevron Nigeria Limited invites interested and pre-qualified companies for this tender opportunity for the Provision of one (1) fixed wing aircraft Services with 70 to 120 passenger capacity whose performance and landing/take-off requirement fits the Escravos runway profile and data as contained in the Nigerian Aeronautical Information Publication (AIP) to support NNPCL/CNL Joint Venture Operations.

The proposed contract commencement is 3rd Quarter of 2024, with a proposed term of five years plus a two-year option to extend.

(2) SCOPE OF WORK:

The Services to be provided includes turnkey services and not limited to:

- (A) Provision of fixed wing aircraft services for the transport of Company and Contractor personnel and materials
- (B) The Provision and Operation of the fixed wing aircraft with 70 to 120 passenger capacity whose performance and landing/take-off requirement fits the Escravos runway profile and data as contained in the Nigerian Aeronautical Information Publication (AIP).
- (C) The required crew and maintenance support in line with the latest Chevron Aviation

Standards.

- (D) Operation of the fixed wing aircraft must be supported from the contractor's owned and operated passenger handling facility at Murtala Muhammed Airport, Lagos, or an alternative facility acceptable solely at Company's discretion to locations required by the Company.
- (E) Daily transportation services between Lagos, Escravos, and Warri, for a minimum of six (6) days a week.
- (F) The estimated number of flying hours per month is 100hrs.
- (G) Compliance with the latest Chevron Aviation Standards for aviation equipment, personnel experience, and safety management requirements for operators.
- (H) The provision of all experienced support personnel required for flight planning, ground handling, dispatching and flight operations to support the aircraft operations as outlined in the Chevron Aviation standards document.
- (I) Demonstration of the requisite capacity and a documented plan to provide an alternative aircraft in the event that the primary aircraft is unserviceable or otherwise unable to operate as required by Company.

- (C) Tenderer shall comply with the latest approved version of NCDMB HCD guideline by committing (via a letter of undertaking) to providing Project-Specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered trainees) or other approved NCDMB training institution(s) of training services in specific technical disciplines involved in the project.
- (D) Provide corporate organizational and project/contract specific organogram. CVs of all personnel listed in the project organogram should be submitted. For any position to be occupied by Expatriate personnel, tenderer shall commit to obtaining expatriate quota approval from NCDMB before project execution.
- (E) Tenderer to provide either of the under-listed document demonstrating capacity to execute the work scope:
- (i) Category 1,2, 3, or 4 Construction and Moveable equipment demonstrating ownership of the fix winged aircraft.
- (ii) Category 1,2,3, or 4 Non moveable assets NCEC demonstrating capacity to carry out logistic services in the Nigerian Oil and Gas industry.
