3. ELIGIBILITY REQUIREMENTS

j) Reference letter from a reputable commercial bank indicating willingness to provide credit facility for the execution of the project when needed;

k) Unabridged company's audited accounts for the last three (3) years (2020, 2021 & 2022) with turnovers corresponding to the turnovers in the tax clearance certificate;
l) Company's profile with the curriculum Vitae of key staff to be deployed for the project, including copies of their academic/professional qualifications such as CPN and NITDA;
