(A) BACKGROUND

DAI, the implementer of the USAID Nigeria State Accountability, Transparency, and Effectiveness (State2State) project, invites qualified applicants to express their interest in the State2State activity. The purpose of the "State Accountability, Transparency and Effectiveness" ("State2State") Activity is to increase the accountability, transparency and effectiveness of selected states and local governments (LGAs) in Nigeria. This will be achieved by: strengthening governance systems (with a focus on public financial management [PFM] and procurement, as well as monitoring and evaluation) related to the delivery of services in key sectors (basic education, primary health care, and water, sanitation and hygiene [WASH]); increasing government responsiveness to citizen needs and priorities; and improving government and civil society capacity to manage conflict (through work on prevention, mitigation and reconciliation with the same sectoral partners, not stand alone assistance to the police or judiciary). The Activity is presently being implemented in the following six states: Adamawa, Akwa Ibom, Bauchi, Ebonyi, Gombe and Sokoto. The Federal component of the activity is focused on facilitating national engagements that impacts work in the focal states and local governments.

(6) Bank Reference Letter duly addressed to DAI Procurement Committee;

Evidence of Registration with Professional Organizations, Regulatory Bodies,
