(A) INTRODUCTION

(E) ELIGIBILITY AND QUALIFICATION CRITERIA

To meet the pre-qualification requirements, kindly ensure submission of the following documents as submission of incomplete information might result ill a rejection of proposal:

Response Part A - Company and Business Information

- (1) Company profile clearly stating history, list of technical personnel and their qualifications and the services offered.
- (2) Evidence of valid registration with Corporate Affairs Commission (CAC) with (i) Copy of Certificate of Incorporation, (ii) Copy of Memorandum and Article of Association (iii) Copy of forms CAC 2 and CAC7.
- (3) Evidence of updated tax clearance certificate
- (4) Tax Identification Number (TIN)
- (5) Cover Page/Letter on company letterhead the subject should be indicating the category(ies) of service seeking prequalification for. The letterhead should have the company registered address(s), official, functional emails, telephone numbers and all point of contacts (POC's) for the company.
- (6) Each submission should include a contact person's name and number and email address for subsequent correspondence.
- (7) List of technical personnel and their qualifications. (As seen in #1).
- (8) Evidence of professional licenses or certificate of authorization to carry out business

in the designated fields (where applicable).

Response Part B - Details/ History of past performance and financial capacity

- (1) Evidence of possession of experience in the line of field/category you are seeking prequalification. The evidence should include copies of completed Job Orders and Proof of Deliveries (Delivery Notes or Job Completion Notification-certificate), LPO's, Agreements or contracts.
- (2) Evidence of financial capability. (Audited Financial Statement/Management Report).
- (3) Letter of reference from bank addressed to ECEWS.

Response Part C - Pricing information for services/goods offered.

Kindly submit your organization's price list for all goods/services offered.

Selection Criteria:

EOI's will be evaluated by a Selection Committee. The Selection Committee will consider the completeness of the submission to ECEW Procurement needs. Evaluators will neither make assumptions nor draw inferences regarding missing or incomplete information. A review will be carried out to determine interested vendors who have the capacity and who offer best value.

Scoring factors: The objective is to choose the applicant capable of providing quality professional services that will help to achieve the goals and objectives in the designated field of interest.
