c) Evidence of Pension Clearance Certificate valid till 31st December, 2023 (this requirement is only applicable to bidders whose number of staff is 15 and above).

d) Evidence of Industrial Training Fund (ITF) Compliance Certificate valid till 31st December, 2023 (this requirement is only applicable to bidders whose number of staff is 5 and above or the bidder's annual turnover is N50m and above);

e) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 31st December, 2023;

f) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 31/12/2023 or valid Certificate issued by BPP;

g) Sworn affidavit from Court of competent jurisdiction in Nigeria (Federal or State), Including

stamped passport photograph and signature of deponent/declarant;

• disclosing whether or not any officer of the relevant committees of the Federal Airports Authority of Nigeria or Bureau of Public Procurement (BPP) is a former or present Director, shareholder or has any pecuniary interest in the company;

• Confirm that all information presented in its bids are true and correct in all particulars.

• That no director has been convicted in any county for any criminal offence relating to fraud impropriety or criminal misrepresentation of falsification of facts relating to any matter.

• That the company is not in receivership, the subject of any form or bankruptcy proceedings of the subject of any form of winding up petition or proceeding

• That the company does not have existing loan or financial liability with a bank, other financial institutions of third party that is classified as doubtful, non-performance, bad or whose repayment portion has been outstanding for the last four (4) months.

h) Company's Audited Accounts for the last three years (2020, 2021 & 2022)

i) Evidence of financial capability to execute the project by submission of Reference letter from a reputable commercial bank indicating willingness to provide credit facility for the execution of the project when needed;

j) Company's profile, with Curriculum Vitae of key personnel showing verifiable evidence of their academic, professional qualifications and experience including membership of professional qualifications and experience including membership of professional regulatory bodies.

k) Verifiable documentary evidence of at least three (3) similar jobs completed/ongoing` project in the last five (5) years including letters of awards, Contract Agreements, job completion etc;

I) Clear indication of Head office address (PCN) registered Premise of the company quoting (applicable to lot 1 only)

m) Letter of introduction

n) Superintendent Pharmacist current license to practice for the year 2023 (Not Applicable to lots 2 & 3)

o) Manufacturers, Dealers/Approved Representatives of the Medical equipment as approved by the Bureau of Public procurement (Applicable to lots 2 & 3 only)

p) Installation of equipment and training on operation of equipment (Applicable to lots 2 & 3)

q) For supply of Equipment: letter of authorization from the Original Equipment

Manufacturer(s) or evidence of proficiency in the installation and training on operation of

such equipment is required.

r) All documents for submission must be submitted with a Covering/Forwarding letter under the Company's letter head paper bearing amongst others, the Registration Number (RC) as issued by the CAC, Contact Address, Telephone Number (preferably GSM No) fax and email address. The letter head paper must bear the Names and Nationalities of the Directors of the company at the bottom of the page, duly signed by the authorized officer of the firm.
