The services of the consultant include to express a professional opinion as to whether (i) the Project Financial Statements (PFS) show true and fair view of the Project's financial position as of 31st December, 2023 and funds receipts and expenditures Incurred during the period then ending. The Audit opinion should also state whether the Procurement Guidelines of the Islamic Development Bank have been properly applied and in accordance

The services of the auditor shall be for a period of 4 years starting from 2023 to 2026 with an estimated 3months professional staff month. The assignment will start immediately after signing the contract and for the subsequent years upon receiving a request letter for commencement.

- (3) Firm's Specific experience in auditing Multilateral Development Banks (MDB) funded projects in the country.
- (4) Availability of relevant personnel in the Firm.

The Qualifications and Experiences of Key Experts shall not be included in the shortlisting criteria. Key Experts shall not be evaluated at this stage.

In the case of a Joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract if selected.

A consultant will be selected in accordance with the Least Cost Selection (LCS) method set out In the Procurement Guidelines.
