The consulting services ("the services") include transforming agricultural practices; promoting a holistic and sustainable approach that benefits farmers; communities, and the environment; Develop training manuals and guides on Good Agricultural practices on Tomato, Rice, Groundnut and Sesame; Conduct pre- and post-training evaluations to provide information on the knowledge level of training beneficiaries. **More details on this consulting services are contained in the Terms of Reference (TOR) which can be obtained from the address below between 10am - 4pm on working days or obtained from the website: [sapz.gov.ng](http://sapz.gov.ng).** It is expected that this consultancy service shall be for a period of **60 days** within which the consultant shall accomplish all the tasks including submission of final report to the Client.

This request for expressions of interest (REOI) follows the General Procurement Notice that appeared on the IFAD website on 17<sup>th</sup> April, 2023, on UNDB on 17<sup>th</sup> April, 2023 and on Thisday and Daily Trust newspaper on 17<sup>th</sup> April, 2023. The attention of interested

consultants is drawn to IFAD's Anti-Money Laundering and Countering the Financing of Terrorism Policy[1] and the Revised IFAD Policy on Preventing Fraud and Corruption its Activities and Operations[2]. The latter sets forth

Consultants have an ongoing obligation to disclose any situation of actual, potential or reasonably perceived conflict of interest during preparation of the EOI, the selection process or the contract execution.
