(vi) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 31/12/2023;

(vii) Sworn Affidavit disclosing whether or not any officer of the relevant committees of the Federal Polytechnic, Mubi, Adamawa State or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars;

(viii) Company's Audited Account for the last three (3) years (2020, 2021 and 2022)

(ix) Reference Letter from a reputable Commercial Bank indicating willingness to provide credit facility for the execution of the project when needed;

(x) Company's profile with the Curriculum Vitae of the Key Staff to be deployed for the project, including copies of their Academic/Professional qualifications;

(xi) Verifiable document evidence of at least three (3) years similar jobs executed in the last five (5) years.
