#### (1) BACKGROUND

#### (3) ELIGIBILITY; REQUIREMENTS

- (a) Evidence of Certificate of Incorporation issued by Corporate Affairs Commission (CAC) including Forms CAC1.1 or CAC2 and CAC7.
- (b) Evidence of Company's Income Tax Clearance Certificate for the last three (3) years valid till 31st December 2023; with minimum average annual turnover of N400 Million.

## (g) Sworn Affidavit:

- Disclosing whether or not any officer of the relevant committees of the Federal Polytechnic of Oil and Gas, Bonny, Rivers State or Bureau of Public Procurement (BPP) is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars.
- That no director has been convicted in any country for any criminal offence relating to fraud impropriety or criminal misrepresentation of falsification of facts relating to any matter.
- That the company is not in receivership, the subject of any form or bankruptcy proceedings of the subject of any form of winding up petition or proceeding.
- That the company does not have existing loan or financial liability with a bank, other financial institutions of third party that is classified as doubtful, non-performance, bad or whose repayment portion has been outstanding for the last four (4) months.
- (h) Company's Audited Accounts for the last three years (2020, 2021 and 2022) duly acknowledged by the Federal Inland Revenue Service (FIRS);

- (i) Reference letter from a reputable commercial bank indicating willingness to provide credit facility for the execution of the project when needed;
- (j) Company's Profile with Curriculum Vitae of key staff to be deployed for the project, including copies of their academic/professional qualifications such as COREN, QSRBN, ARCON, CORBON etc.;
- (k) Lot 2: Letter of authorization as representatives of the original equipment manufacturers (OEM);
- (l) Veritable documentary evidence of at least three (3) similar jobs executed in the last five (5) years including letters of award, valuation certificates, job completion certificate, photograph of the projects;
- (m) Works: List of plants/equipment with proof of ownership/lease agreement;
- (n) For Joint Venture/Partnership, Memorandum of Understanding (MoU) should be provided (CAC, Tax Clearance Certificates, Pension Clearance Certificate, ITF Compliance Certificate. NSITF Clearance Certificates, IRR & Sworn affidavit are compulsory for JV Partner);
