1. INTRODUCTION

To this effect, suitably qualified contractors with good track records are invited to apply for TENDER FOR GENERAL MAINTENANCE REPAIRS OF SOME FEDERAL ROADS NATIONWIDE.

2. SCOPE OF WORKS;

The scope of works includes, but not limited to:

Site clearance, desilting of existing drains and culverts, construction of new drains and culverts, scarification of failed sections, earth works on completely failed areas, general bridge maintenance, protective works, kerbs, latrine/cement stabilized sub base, crushed stone base course, asphaltic concrete binder and wearing courses, surface dressing, side drains, roads markings and other road furniture.

3. ELIGIBILITY REQUIREMENTS

Prospective bidders must possess the following eligibility criteria to be able to participate bidding process:

- i. Colour copy of Evidence of incorporation with Corporate Affairs Commission (CAC) as Limited/Public Liability Company including copy of certified Memorandum and Articles of Association as well as forms CAC 2 and CAC 7.or MEMERT
- ii. Colour copy of Company Tax Clearance certificate for the last three (3) years valid till 31st December 2023; with minimum average annual turnover of N50 million.
- iii. Colour copy of Evidence of Pension Clearance Certificate valid till 31st December, 2022 (this requirement is only applicable to bidders whose number of staff is 15 and above).
- iv. Evidence of Industrial Training Fund (ITF) Compliance Certificate valid till 31st December, 2023 ; (this requirement is only applicable to bidders whose number of staff is 5 and above or the bidder's annual turnover is N50m and above);
- v. Colour copy of NSITF Compensation Act compliance certificate valid till 31st December 2023.
- vi. Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 31/12/2023 or valid Certificate issued by BPP;
- vii. A Sworn Affidavit dated not earlier than 31st October, 2022 :
 - disclosing whether or not any officer of the relevant committees of the Polytechnic, Ibadan or the Bureau of Public Procurement (BPP) is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars;
 - Indicating that all documents submitted are genuine and verifiable
 - That none of the directors nor the Company itself has been convicted of any criminal offence in any country including financial impropriety.
 - That the bidder is not in receivership, the subject of any form of winding up petition or proceeding.
- viii. Verifiable evidence of equipment and technology capacity relevant to the projects including proof of ownership/recent lease agreement.
- ix. Documentary evidence of at least three (3) similar works to the proposed projects, successfully carried out within the last three (3) years (2020, 2021 and 2022) with names of client, evidence of award letter(s) and Interim Certificate of Valuation either ongoing or job

completion certificate.

x. Company's profile including organizational structure, key professional staff with their names, stating their roles, designation, qualification and years of experience and telephone numbers, at least two (2) of which must be a COREN registered Civil Engineer with 2023 Engineers Practicing License, including photocopies of endorsed professional certificates

xi. Audited annual financial report of the company for the last three years (2020, 2021 and 2022)

xii. Evidence of financial strength by submission of reference letter from reputable commercial bank in Nigeria, indicating willingness to provide credit facility for the execution of the project to the tune of not less than N50m in addition to evidence of average annual turnover of at least N50m in the last three years (2020, 2021 and 2022)

xiii. For Joint Venture/Partnership, Memorandum of Understanding (MoU) should be provided (CAC, Tax Clearance Certificate, Pension Compliance Certificate, ITF Compliance Certificate, NSITF Compliance Certificate, IRR & Sworn Affidavit are compulsory for each JV partner)

xiv. All documents for submission must be transmitted with a Covering/Forwarding letter under the Company/Firm's Letter Head Paper bearing amongst others, the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone Number (preferably GSM No.), and e-mail address. The Letterhead Paper must bear the Names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorized officer of the firm.

xv. The offer must be properly signed.

xvi. All schedules provided in bid documents must be completed

xvii. All bids must be submitted in English language.

xviii. Inclusion of the complete FERMA Standard Bidding document correctly and completely filled and signed appropriately.
