The Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH: “Integrated Approach to climate change in Rice Production system in Nigeria – GIAE NG- InACC Programme”, financed by the Federal Ministry of Economic Cooperation and Development of Germany and the European Union, would like to procure via a “Negotiated Award Procedure” the following Agroforestry Tree Seedlings in Five (5) lots to be distributed within Nigeria:
