ii. Configure the new setup in a secured manner that will not require the use of VPN to access the application.

iii. The new application should be deployed in a way that will allow users access the server by not going through VPN, the app should be accessed over the internet without using VPN. iv. Daily incremental backup and weekly full backup. Backup should be configured to a third-party Cloud provider, like Azure.

v. Setup a disaster recovery policy on the cloud on the cloud platform.
