The method of payment will be by certified Bank Draft in Favour of IFAD assisted Livelihood Improvement Family Enterprise Niger Delta (LIFE-ND) Project, Cross River State, The Bidding Documents can be collected by the representative of the Bidder on request.

(3) Bids must be delivered to the address below at or before **12:00noon local time** for Serial Nos. 1 & 2 and **2:00pm local time** for Serial Nos. 3 & 4 respectively in the table above **on Monday, 6 November, 2023**. Late bids will be rejected. Bids will be opened in the presence of the bidders' or representatives, who choose to attend at the address below **on 6 November, 2023** as follows: Serial Nos. 1 & 2 at **12:00noon local time** for Serial Nos. 3 & 4 at **2:00pm local time**. All bids must be accompanied by a Bid Security as stated in the table above in local currency.
