(1) INTRODUCTION

KEDCO has the license for the distribution and sale of electricity across three states – Kano, Katsina and Jigawa. KEDCO is required to maintain power availability, reliability & quality in line with prevailing Nigerian regulations as set by the Nigeria Electrical Regulatory Commission (NERC) in their Customer Service Standards of Performance, together with internationally accepted standards (IEC 60050).

In achieving this mandate, KEDCO is developing Renewable Energy and Embedded Generation projects to improve supply availability and reliability within its franchise area.

(2) **PROJECTS COPE**

KEDCO is seeking qualified Energy Services Companies to collaborate with to provide improved electricity supply to selected Feeders / Clusters within its service territory. Successful applicants will be included in a repository of Prequalified Organizations that will be eligible to participate in future procurement processes to develop, finance, build, own and operate renewable energy systems comprising solar photovoltaic ("PV"), energy storage, and diesel or natural gas generation. The systems will be designed to serve different types of customers such as a large industrial cluster, a group of small and mediumscale agro-processors, or a single large commercial/industrial customer in KEDCO's service territory.
