 - (ix) Evidence of compliance with Section 6(1) - (3) of the ITF Amendment Act No. 19 of 2011 for the last one (1) year.
 - (x) Evidence of Registration with COREN, PENCOM, ITF and NSITF.
 - (xi) Evidence of Business premises license.

(3) Collection of Tender Documents
