**Note:** The project involves Improvement of an existing rural feeder road having a total length of 18.2 km. The works include but not limited to; Site clearance and Earthwork, Culverts and Drains, Pavement and Surfacing as well as strict undertaking of Social and Environmental Safeguard. The work is expected to be completed within 18 months.
