(1) The Federal Republic of Nigeria has received financing from the World Bank toward the cost of the EKITI State Adolescent Girls' Initiative for Learning & Empowerment Project, (EKITI AGILE), and intends to apply part of the proceeds toward payment under the contract for the Procurement and Distribution of Laptops with Disability Assistive Electronic Devices and Software, Entrepreneurial Equipment, Mobility Aids and Braille Press for 3 Special (Disability) Schools in Ekiti State in Lots.

(3) Bidding will be conducted through National Competitive Procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" Procurement in Investment Projects Financing" November 2020 ("Procurement Regulations") available on [www.worldbank.org/procure](http://www.worldbank.org/procure) and is open to all Bidders as defined in the Procurement Regulations.

(4) Interested eligible Bidders may obtain further information from the office of the EKITI State Adolescent Girls' Initiative for Learning & Empowerment Project, (EKITIAGILE) and inspect the bidding document during office hours from 9:00 am to 4:00 pm (local time) at the address given below.

(5) Qualifications required include:

- (i) Certificate of Incorporation with Corporate Affairs Commission (CAC).
- (ii) Evidence of Previous Supply/installations of similar equipment carried out in the range of bid price in the past five (5) years.
- (iii) Audited financial statements for the last three (3) years to demonstrate financial capability/soundness of the Bidder.
- (iv) Evidence of registration with professional organizations/body.

(v) Evidence to provide After-Sales/Installation services.

(vi) Certificate of Manufacturers' Authorization

Margin of preference shall not be allowed

(6) Bidding document in English may be purchased by interested eligible Bidders upon the submission of a written application to the address below' and upon payment of a non-refundable fee of Twenty Thousand Naira (N20,000.00) only in a Bank Draft in favour of Ekiti State Adolescent Girls' Initiative for Learning & Empowerment (AGILE) Project. The bidding documents could be collected at the address below on presentation of proof of payment. At the request of the bidder, the documents could also be sent by courier after payment of an additional fee to cover the cost of delivery.

(7) Bids must be delivered to the address in paragraph 9 below **on or before Monday, 20 November, 2023, 12:00 pm** (local time) Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below at **12.00 noon on the Monday, 20 November, 2023**. All Bids must be accompanied by a Bid Security of at least 2.5% of Bid price.
