

mothers2mothers (m2m) is an African Primary Health Care organization that employs women living with HIV as community health workers across 10 African nations. These “Mentor Mothers” deliver integrated health services at clinics and in communities to ensure everyone, everywhere, has access to the services they need to be healthy and stay in care. Over the next five years, this proven, peer-led model is being scaled up to double down on ending HIV, as well as to tackle new health challenges and reach more people – all with the aim of building a fairer, healthier future. The employment of local women as community health workers means that we are delivering a model that prioritizes healthcare for families who need it most, delivered by women who know them best. Since its creation in 2001, m2m has created jobs for nearly 12,000 women living with HIV in sub-Saharan Africa and, together, they have reached over 15M people with critical health services and education.

In 2021, m2m reached over 1.6M people across 10 African nations, including 402,616 adolescents (ages 10-19) – 51% more than the year before. m2m also advanced the Global Goals of ending HIV/AIDS by 2030 – by achieving virtual elimination of mother-to-child transmission of HIV among its enrolled clients for the eighth consecutive year, and meeting all of the ambitious UNAIDS Fast-Track Targets among its clients four years ahead of the 2026 target date.

Objective of the Assignment

- m2m Nigeria seeks to employ the services of an eligible and reputable Insurance company to submit proposals for Group Life Assurance and Group Personal Accident (GLA/GPA) Services to all staff members in Nigeria.

Purpose

- The main purpose of the service is to provide high quality, client focused and cost-effective GLA/GPA services to all m2m Nigeria employees. The organization is expected to

act with high degree of integrity, responsibility and be knowledgeable as well as compliant with National Insurance Commission Act/Laws.

- To provide corporate GLA/GPA services in the areas death, accident, temporary or permanent disability while in active service with m2m Nigeria.

Expected Deliverables

The expression of interest shall be sought appropriately from qualified firms to provide the under-listed services:

- The Group Life Assurance Policy shall provide cover to insured against death, temporary and permanent disability.
- The insurance cover shall be covered for a period of one year; subsequent renewal shall be subject to performance.
- The premium payable on the GLA/GPA Policy shall be pro-rated as applicable when an employee joins the organization.
- When an employee leaves the service of the employer before the 12 months' expiration period, the insurance company shall refund or set aside to the credit of the employer the premium relating to the unexpired period.
- The insurance cover shall be mandatory to all employees as long as they are in active/full term employment.
- The insurance company shall ensure that the employer complies with the minimum insurance cover of three times of the annual total emolument for each employee.
- Annual Total Emolument (ATE) for the purpose of the Group Life Assurance Policy under PRA 2014 shall be the gross emolument of the employee.

Quote Validity

- Vendor proposals shall remain valid for one year from the deadline for receipt of quotations. Additionally, for the successful bidder(s), the bids/quotes submitted shall also remain valid and not subject to review for a one-year period from the date of contract signing by the selected Insurance Company.

Duration of Contract

- The Contract period shall be from November 2023 to September 2024 subject to good

performance in the first year of engagement.

- Your Company must be registered in compliance with the Company and Allied Matter Act of 1990 as a Limited Liability Company and accredited by the National Insurance Commission of Nigeria (NAICOM) with the requisite experience and records of accomplishment for provision of GLA/GPA services.
