(ii) Accompany with a soft copy of all documents submitted on a USB Flash Disk

(iii) To be registered and dropped in the appropriate Tenders Box in the office of the

Director Tenders Board Secretariat, National Assembly (Room 1,279, Annex 1, National Assembly Complex) not later than **2pm on the 15 April, 2024.**

(i) All submissions would be verified from relevant agencies like the FIRS, NSITF, CAC PENCOM etc;

(ii) National Assembly reserved the right to reject any Tender documents;

(iii) This Invitation should not be considered to be a commitment on the part of the National Assembly to have entered into any form of contract with any company to make any claim whatsoever from the National Assembly;

(iv) All costs incurred as a result of this Tender Invitation and subsequent requests for information shall be home by the bidding companies;

(v) The tender bid should be very clear about the Bidders area of competence and interest;

(vi) Proposal for different procurement LOTs should be submitted indifferent envelopes;

(vii) Late submission would be rejected;
