The Federal Government of Nigeria has received financing from the World Bank toward the cost of the Agro Climatic Resilience in Semi-Arid Landscape (ACReSAL) Project and intends to apply part of the proceeds toward payments under the contract for Reconstruction of Lugu Dam Embankment.

The Bidding document in English Language may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of **Sixty Thousand Naira NGN60,000.00 or USD 75.00 for bidders outside Nigeria.** The method of payment shall be by Bank Draft (Bankers Cheque) in favor of Sokoto State Agro Climatic Resilience in Semi-Arid Landscape (ACReSAL) Project.
