INVITATION FOR PRE-QUALIFICATION & TENDER FOR PROJECT

Taraba State Universal Basic Education Board (TSUBEB) hereby invites submission of proposals from suitably qualified Company/Firms for pre-qualification for the construction of classrooms, renovation of dilapidated classrooms, construction of perimeter fencing, drilling of solar and hand pump boreholes and the supply of classrooms and teachers furniture, ECCDE plastics and equipment across the selected schools in the state. Approval for the implementation of 2023 Matching Grant has been granted. The action plan is guided towards the aforementioned.

(II) SCOPE OF PROJECTS

- (1) Construction of adult literacy/women development centres and VIP toilets in some selected ECCDE primary schools in the State.
- (2) Rehabilitation of classrooms and Toilets.
- (3) Drilling of Solar and Hand pump Boreholes
- (4) Construction of perimeter fence
- (5) Supply of ECCDE plastic furniture and equipment

(II) ELIGIBILITY CRITERIA FOR THE AWARD OF CONTRACTS AT THE BOARD.

- (v) Audited accounts for 3 subsequent years (2021-2023).
- (vi) TIN Number
- (vii) ITF Compliance certificate.
- (viii) PENCOM Compliance certificate
- (ix) NSITF Compliance Certificate.
- (x) BPP Interim Registration.
- (xi) SCUML Certificate (EFCC)
- (xii) Similar jobs successfully executed with evidence of Completion.
- (xiii) Technical capability and list Company equipment.

(III) GENERAL CONDITION

- (A) All pre-qualification documents are to be bound and sealed in an envelope with the "Pre-Qualification" and to be submitted to the office of the Procurement Officer TSUBEB, Jalingo not Later than 14 days from this advertisement (date of advert: 27 March, 2024).
- (B) The Pre-Qualification documents should be opened by **12 Noon same day (24 April, 2024)** at the premises of the New Board Office, Opposite De-Bas Hotel, Hammaruwa Way, Jalingo.
- (C) Pre-Qualified Companies/Firms shall be inform of the outcome of assessment not later than fourteen (14) days after opening of (PQ) documents.

(D) Pre-Qualified Companies/Firms are to pay a Tender Fee of N50,000 prior to the commencement of the Project and or collection of Tender documents.

(E) Final list of Assessment will be made public after two (2) weeks from this date.

NOTE: Only Pre-Qualified Companies/Firms will be invited for Tender, full and appropriate bidding procedures shall only be applied to Companies that have been pre-qualified.
