# (1) GENERAL REQUIREMENTS & SCOPE OF WORK

The objective of the audit of the Financial Statements is to enable the auditor to express a professional opinion on the financial statements at the end of the reporting period and of the funds received and expenditures for the reporting period, in all material respects, been used in conformity with the provisions of the donors, including any amendments thereto as contained in implementation letters, and any applicable guidelines in force and applicable to the audit scope, and with due attention to economy and efficiency.

To confirm that the Financial Statements agree with the general ledger (books of account) and Trial Balance (TB) which provide the basis for preparation of the Financial Statements and are established to reflect the financial transactions in respect of all interventions, as maintained by TechnoServe Nigeria.

To ascertain that the Financial Statements agree or reconcile with any other information reported to TNS using International Financial Reporting Standard (IFRS).

The audit will be carried out in accordance with International Standards of Auditing (ISA). It will include such tests and controls as the auditor considers necessary including any visits to TNS operation office across the country. Representative sampling may be used as the auditor considers necessary.

# Specific focus will be:

- To establish that the funds have been recorded and funds have been expended in accordance with the terms and conditions of the contract.
- $\cdot$  Items and services have been procured in accordance with the guidelines included in the contract.
- $\cdot$  Necessary supporting documents, records and accounts have been kept in respect of all TNS expenditure.
- To establish the physical existence of TNS-funded project assets per the asset

register, their conditions and locations.

- $\cdot$  Whether the systems, procedures and controls, contractual or otherwise, adopted by TNS are efficient, effective and transparent.
- · Whether these systems, procedures and controls enable TNS to discharge its contractual obligations to donors including its financial and project management obligations.
- $\cdot$  Whether improvements to TNS systems, procedures and controls can be made as a result of the findings of this audit.
- Whether the funds in TNS account were deposited, transferred and expensed properly in compliance with TNS guidelines and other relevant financial policies and procedures as may be stipulated under the TNS donor contracts.

### Methodology

The approach should include but not be limited to using sample selection:

- $\cdot$  Hold separate pre-engagement meetings with the TechnoServe Nigeria to present an outline of the planned approach for conducting the exercise.
- Request and hold formal interviews with the financial management team with a view to forming an understanding on the effectiveness of TNS's internal control system.
- Examination of the financial transactions of the various projects under the management of the Company for the above period in line with expectations set out in TNS financial policy (to be made available after the contract has been executed).
- Review and vet invoices for fees and reimbursable expenses
- $\cdot$  Deliverables from short and long term consultancies were properly delivered and received before relevant costs were charged to TNS.

- (1) Review and vet bills paid for services rendered by contractors and ascertain that:
- (2) Services billed in the period under review are covered in the relevant sub-contracts.
- (3) Contractually agreed deliverables have been achieved and approved by appropriate authority within the Company.
- (4) Review the procurement process and procedures for short term contracts for the period under review and ascertain that:
- (5) Transparent and open systems are in place to ensure negotiations for contracts (services, works and printing) are competitive and represent good value for money.
- Review the assets register to ensure it is up to date and confirm that.
- The physical existence and conditions of assets in project sites.
- Express an opinion on the cost effectiveness, accuracy and completeness (i.e. value for money) of the financial transactions for the period under review.
- · Review grant, sub-grant processes and procedures
- Bring to the attention of TNS any suspected fraud or irregularity that arises during the course of the audit and communicate matters that have come to attention during the audit which might have a significant impact on the implementation of TNS projects.
