(1) The Federal Government of Nigeria through the Federal Ministry of Agriculture and Rural Development has received financing from the World Bank and French Development Agency toward the cost of the Rural Access and Agricultural Marketing Project (RAAMP) and intends to apply part of the proceeds toward payments under the contract for Construction of 70.18km Rural Roads Spot Improvement in Kano State. This contract will be financed by the International Development Association (IDA). Procurement process will be governed by the World Bank's Procurement Regulations.

(2) The Kano State Project Implementation Unit, Rural Access and Agricultural Marketing Project now invites sealed Bids from eligible Bidders for the Construction of 70.18km Rural Roads Spot Improvement in Kano State grouped into 5 lots as follows;
