Quotations are due by **February 24, 2024**, by 4.30pm (local time). No quotations will be accepted after this time. Proposals must be in English and incomplete proposals will not be accepted.

Your quotation must be submitted electronically to **Abujaprocurement@state.gov**. It is important to make sure the submission is made in specific size and format; in MS-Word 2007/2010 or MS-Excel 2007/2010 or Adobe Acrobat (pdf) file format. The file size must not exceed 30MB. If the file size should exceed the 30MB, the submission must be made in separate files and attached to separate emails with less than 30MB each.

For a quotation to be considered, you must also complete and submit the following:

Detailed proposal, which must be submitted in two separate attachments ONLY (but in one

email) as follow:

- (a). Technical proposal to include but not limited to your methodology for meeting the requirement, performance schedule, proof of SAM Registration and UEI number, proof of experience with valid contact information of your customers for the past five (5) years, ETC.
- (b) Financial proposal in the format provided in the SOW.

- 3. Section 5 Representations and Certifications
- 4. Additional information as required in Section 3
- 5. The Offeror should submit a completed IRS Form W-14, found at **www.irs.gov/w14**, to ensure compliance with FAR 52.229-11;"
- 6. Evidence of financial capability as payment term is Net 30
- 7. The Offeror shall include Defense Base Act (DBA) insurance premium costs covering employees. The offeror may obtain DBA insurance directly from any Department of Labor approved providers at the DOL website

Offerors shall be registered in the SAM (System for Award Management) database at https://www.sam.gov prior to submittal of their offer/proposal as prescribed under FAR 4.1102. Therefore, offerors are highly encouraged to register immediately if they are interested in submitting a response to this requirement.
